Important information – Communication Consent

- You can grant consent to all the purposes; one of the purposes or none of the purposes listed
- Where you do not grant consent, we will not be able to use your personal data; (so for example we may not be able to let you know about particular forthcoming activities and events outside of our Scout Group's activities); except in certain limited situations, such as where required to do so by law or to protect members of the public from serious harm.

- Please note that all processing of your personal data will cease once you have withdrawn consent, other than where this is required by law, but this will not affect any personal data that has already been processed prior to this point.

Important information – Photograph Consent

- Even if you do not give consent, we cannot guarantee that photographs/videos will not be taken and shared by members of the public when we are in public locations.
- If you give consent, we will not use your child's full name when sharing photos/videos
- You can withdraw your consent at any time by contacting your child's Leader
- All photographs and videos are kept in compliance with current GDPR requirements
